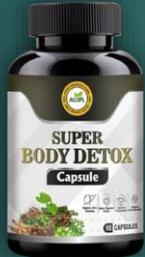

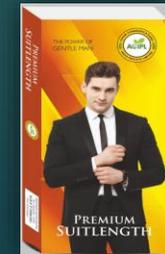

### 3. TRAINING & MOTIVATION INCENTIVE (TMI)

ACIPL EXPECTS FROM ITS TEAM LEADERS TO CONSTANTLY PROVIDE EDUCATION, TRAINING AND MOTIVATION TO HIS/HER TEAM DIRECT SELLERS. TO ENCOURAGE AND REWARD THE EFFORTS OF ITS TEAM LEADER/ DIRECT SELLERS, ACIPL HAS ALLOCATED 45% OF ITS MONTHLY RSPTO. EVERY DIRECT SELLER WHO HAS MADE FIRST PURCHASES OF AT LEAST 1000 BVs AND HAS MADE A REPEAT SALE/PURCHASE IN THE CURRENT ACCOUNTING MONTH SHALL BE ELIGIBLE FOR THIS INCENTIVE IN THE RATIO OF THE SALE/PURCHASE MADE BY HIM/HER.
